

Sleepy Driver






Dodge Ram vs GMC Denali









Crashes Involving Drivers 16-19 Years Old 2023 Statewide Statistics

In 2023, there were more than <u>49,975</u> people, just in North Carolina, injured or killed in crashes involving 16-19 year old drivers.

It Can't be That Dangerous to Drive...or is it?



Most fatal teen crashes occur between 9 PM and 3 AM Reducing teen passengers in a car has substantially reduced fatality rates 28% of teen driver fatalities involve a B.A.C of .08 or more


There were **105** teens from 15-20 years old killed in vehicle crashes in North Carolina in 2023.

In 2023 in Guilford County, there was 1 teen between the ages of 15-20 killed in traffic crashes.



Seatbelts Save Lives...

The driver of a stolen van was killed after fleeing police and crashing into a pole on. A Guilford County Sheriff's deputy chased the stolen van through two counties in the early morning hours before it eventually crashed into a utility pole inside the city limits of Reidsville. The driver was pronounced dead at the scene. According to police, speed was a factor in the crash, and stated the driver was not wearing his seatbelt and was partially ejected from the vehicle.

High Point Crash Kills Students



This crash claimed the lives of two High Point students and injured two others when their vehicle crashed and flipped. None of the occupants were belted. Their speed was 65 MPH in a 35 MPH zone. None of the occupants of the other car were hurt, all of whom were belted.





This crash occurred when a truck crashed into a utility pole in High Point. The unbelted, 25-year-old driver and the belted, 17-year-old passenger were both killed. Investigators say the vehicle was traveling about 90 mph when the driver lost control. The driver's BAC was 0.13.

High Speed With Seatbelt
















The Honda crotch rocket rider was traveling at approximately 85 mph. The VW driver was talking on a cell phone when she pulled out from a side street, apparently not seeing the motorcycle. The rider's reaction time was not sufficient enough to avoid this collision. The car had two occupants and the bike rider was found INSIDE the car with them. The Volkswagen actually flipped over from the force of impact and landed 20 feet from where the collision took place.

All three involved (two in the car and the bike rider) were killed instantly.

Talking & Texting

Any driver caught texting while driving will face a fine of \$288.

Train – car collision

December 22, 2009 in Efland, NC a 26-year-old woman and her 5-year-old son were killed and her 4-month-old daughter was injured when she drove through a railroad crossing into the path of an Amtrak train. It was determined the woman was talking on her cell phone when the crash occurred.



Texting & It's Deadly Consequences

A truck driver was texting while driving down the highway at 70 MPH. The driver began to merge into a lane of travel and did not see the 16 year old female driving beside him. As a result of texting, the driver continued to merge into the lane. The 30,000 pound tractor trailer slammed into the female's car pushing it 350 feet down the road, killing the driver.



Texting While Driving



Brittany Johnson died in a car crash in North Carolina in 2009. Her cell phone was found beside her body with an unfinished text message.



An amazing journey of courage, determination and devotion


Jackie's Story





In 1999, 20-year-old Jacqueline Saburido left her family and friends in Venezuela to come to Austin, Texas.

She traded flamenco dancing and jet skiing for an adventure in a new country and the chance to learn English.



Reggie Stephey was a senior at Lake Travis High School near Austin. He played baseball and football.

College was in his future.

One of his prized possessions was the SUV he had customized.



Early one Sunday morning in the fall of 1999, Jacqui's and Reggie's paths crossed.

In a split second, their lives would be changed forever.



Just a few hours earlier, Jacqui had been at a birthday party with some of her new friends.

It was late when they left the birthday party.

Neither she nor the driver had been drinking.

That same Saturday, Reggie met some friends after work and had a few beers.

Later, he went to a party and drank some more, even though he was under twenty-one.





At the same time Jacqui was on her way home, Reggie was driving home, too.

But he was drunk

On a four-lane road just outside of Austin, Reggie's SUV crossed the centerline and hit the car Jacqui was riding in, head-on.



Two of Jacqui's friends died instantly. Jacqui's legs were pinned in the car.

Trapped, Jacqui begged for help, but rescuers could not get her out.

A fire started in the engine and spread to the inside of the car.

Engulfed in flames, she screamed for 45 seconds.

Then there was silence.

Other than a few bruises, Reggie was OK except for one thing.

A blood test showed he had been drinking. Police officers arrested Reggie and took him to jail.

Jacqui was barely alive when she arrived at the hospital. She was burned over most of her body.

Her hair was gone.

So were her nose and her ears.

Her eyes were scorched.

She was almost completely blind.


Fingers on both of her hands had to be amputated.

The pain was indescribable and constant. Jacqui spent months in the hospital. She has had over 120 surgeries.



Reggie Stephey was tried and convicted for causing the deaths of two people while he was driving drunk. He was released from prison in 2008 after serving two concurrent 7-year sentences for manslaughter.

Reggie never thought this could happen to him. He was 28 years old when he was released from prison. The damage he did, he says, is "a pain that will never go away."



Jacqui has had more than 120 operations and is considering a face transplant. To get the medical care she needs, she must live in the United States - far away from family and friends.

Once fiercely independent, Jacqui has come to rely on her father, Amadeo, to take care of her.



Amadeo left his business in Caracas to take care of his only child. He has not left her side since the crash.



Jacqui lives back in Caracas, Venezuela. She faces years of more surgery and medical treatment.



Determined to do what she came to the United States for in the first place, Jacqui completed language classes at the University of Louisville. She is now able to speak and write English.



In May, 2003, after many, many operations to replace her left eyelid that was completely destroyed in the fire, Jacqui was able to have a cornea transplant. The operation was a success, and some of her vision has now been restored.



Jacqui doesn't want anyone else to have to endure the suffering that she has experienced.



In 2002, she appeared in a TV commercial produced by the Texas Department of Transportation to remind people not to drink and drive.

More than 300 million people throughout the world have seen it.

She also appeared on The Oprah Winfrey Show in 2003 and 2011.



A poster with her photograph shows high school and college students and others what can happen as a result of drunk driving.

Ads with Jacqui's picture have appeared in newspapers and magazines in the United States, Canada and Great Britain.







When she is physically able, Jacqui speaks out against drunk driving.

Jacqui's incredible story of courage and determination has touched millions of people throughout the world. Thousands of people have written her letters or sent emails.


